Application and dosage



Neat

Spray on. Leave for a short time to take effect. Dab away from outside in using a clean, absorbent cloth. Remove things like chewing gum with a spatula.



Note

Pressurised container. Do not expose to direct sunlight or temperatures above 50°C. Do not spray onto flames or objects that are aglow. Do not forcibly open or burn, even after use. Use the product within 6 months after opening; otherwise, technical problems cannot be ruled out. Test coloured, sensitive or painted surfaces on an inconspicuous area for colour fastness before application. Note the manufacturer's cleaning instructions.
