Application and dosage

- For absorbent floor coverings such as old linoleum coverings, pre-treatment with Corridor® Basic S 720 is recommended. When used with Corridor® Basic S 720, the appearance, durability and adhesion of Corridor® Complete S 732 to these coverings is significantly improved.
