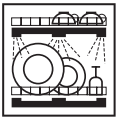

Application and dosage



Dosage is carried out via automatic dosing devices, depending on items to be cleaned and the water hardness:
0,05 - 0,4 ml / 1 l water

Note

Do not mix with other products. Surfaces or objects that come into direct contact with food, freed from cleaning residues by careful rinsing with water. Before changing over to a new product, rinse all containers/compartments, pipes/tubes and dosing devices with fresh water. When you have finished using the dishwasher for the day, clean all sieves. Leave the machine slightly open to ensure that the inside of the machine dries thoroughly and to avoid corrosion. Do not expose product to direct sunlight.
