## Application and dosage

- Always use cold water.

- Do not use on acrylic glass (PMMA).
- When used in the machine, the tanks should be cleaned and rinsed regularly.

- **Environmental:** Feed residual emptied containers to the dual system. For detailed information see environmental information.

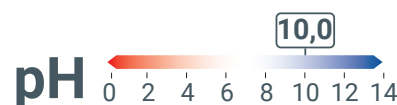
